THE GOAL IS TO PROVIDE FOR ACUTE BASIC NEEDS THAT HELP CLIENTS IN DISTRESS GET BACK ON THEIR FEET AND TAKE STEPS TOWARD STABILITY AND INDEPENDENCE. THE TYPES OF ASSISTANCE INCLUDE: SHELTER, UTILITIES, GAS VOUCHERS, AND BACK-TO-WORK EXPENSES SUCH AS PERMITS, IDS, AND CLOTHING VOUCHERS. DURING 2020-21, ICS SERVED 4,555 HOUSEHOLDS PROVIDING OVER \$4 MILLION IN ASSISTANCE. IN PARTNERSHIP WITH THE COMMUNITY FOOD BANK OF SOUTHERN ARIZONA, ICS FOOD BANKS AND FREE PRODUCE GIVEAWAYS DISTRIBUTE EMERGENCY FOOD BOXES EACH MONTH TO LOW-INCOME SENIORS, INDIVIDUALS AND FAMILIES IN NEED. DURING 2020-21, ICS DISTRIBUTED 4 MILLION POUNDS OF FOOD.

MORE THAN 60% OF MOBILE MEALS RECIPIENTS RECEIVE FULLY OR PARTIALLY SUBSIDIZED MEALS. ICS SERVED 33,138 MEALS DURING THE YEAR.
